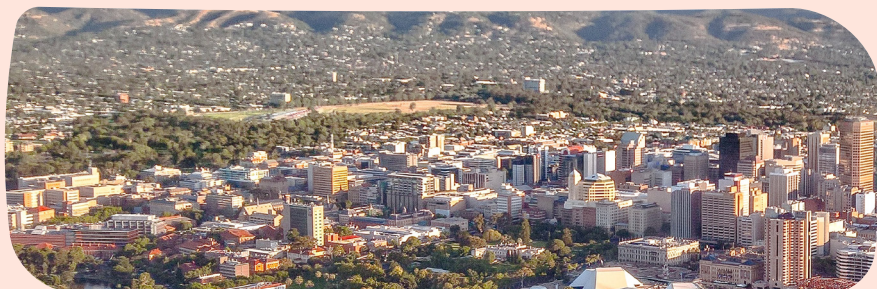

By purchasing a Package, you accept and agree to be bound by that document, including its restrictions on the resale and transfer of Match Tickets.

PRICING

All prices are in Australian dollars (AUD\$) and include all local taxes which in Australia is a 10% Goods & Services tax (GST).

Southern World Australia will invoice in local currency (AUD\$). If payment is remitted in a currency other than the local currency, then Southern World Australia will set the rate of exchange to be applied for payment. Please request a rate just before payment is due.

NON-REFUNDABLE DEPOSIT

A non-refundable deposit equal to fifty percent (50%) of the total Package price is required within 7 days of Southern World Australia confirming your reservation.

By submitting a booking request, the customer acknowledges and agrees that Southern World Australia may immediately request, secure or commit to the Match Ticket(s) and other services associated with the selected Package. Once Southern World Australia has requested, secured or otherwise committed to the Match Ticket(s), the customer becomes financially liable for those Match Ticket(s) and all related costs.

It is the customer's responsibility to carefully review and ensure they have selected the correct Package, Match Ticket(s), match, date, destination and all other relevant booking details before confirming their reservation. Southern World Australia is not responsible for errors made by the customer, including the selection of an incorrect Package, match or Match Ticket(s).

Once Southern World Australia has confirmed the booking and has requested, secured or otherwise committed to the Match Ticket(s), the customer remains liable for the full cost of those Match Ticket(s). If a match is delayed, interrupted, rescheduled, relocated, or played behind closed doors, your Match Ticket and Package will be treated in accordance with the Ticket Terms and Conditions referenced above. Where a Package cannot be delivered as a result, any refund is limited to the affected elements only.

FORCE MAJEURE

Southern World Australia will not be liable for any failure or delay in providing your Package where this is caused by circumstances beyond our reasonable control, including natural disasters, extreme weather, pandemic, industrial action, war, terrorism or government action.
